# <u>Invitation to Tender for Supply of Evacuation Stair Chairs and Med Sleds</u> General Provisions

#### 1.1 Intent

This invitation to Tender is intended to obtain the supply of up to <u>135 Evacuation Stair</u> <u>Chairs and 135 Med Sleds</u> to be delivered to Provincial Health Authority sites. The quantity to be shipped to each location shipping locations are indicated in the specifications in Appendix A.

#### **General Provisions**

The successful vender will be responsible for commissioning and training for the use of the units.

This Tender is concerned with the supply of the specified Equipment with consideration of the following:

- Ongoing service and maintenance support.
- All manuals, documents and initial supplies.
- The right to reproduce any printed materials supplied with the product for the purpose of using the product.
- Training and training manuals.
- Future enhancement availability.
- Products being fully suited, as determined by Western Health professional staff, for intended use and compatible with Western Health's facilities and/or existing equipment.

# 1.2 Client Background

Western Health was established in 2005 by the Government of Newfoundland and is responsible for the delivery of Health and Community Services in the Western Newfoundland Region.

# 1.3 **Vendor Response**

- 1.3.1 Vendor's tender should contain an Executive Summary which shall contain:
  - a. A brief description of the product being quoted.
  - b. The name, title and address of the Vendor's representative responsible for the preparation of the Tender.
- 1.3.2 All prices quoted for goods and services must be specified in Canadian dollars, FOB sites indicated. All Tenders will be held to be valid for ninety (90) days following the Tender closing date.
- 1.3.3 Tenders must be received in full on or before the exact closing time and date indicated. **TENDERS RECEIVED AFTER THAT TIME WILL NOT BE CONSIDERED.**
- 1.3.4 All costs relating to the work and materials supplied by the Vendor in responding to this Invitation to Tender must be borne by the Vendor.

#### 1.4 Release of Information

### 1.4.1 While Tender is Open:

The names of individuals or companies who have picked up the tender documents will not be released.

#### 1.4.2 At Tender Opening:

Only the names of the bidders and bid price will be read out.

# 2.0 **Product Specifications**

The evacuation stair chair must and med sled equipment must meet the following specifications or equivalent:

# 2.1 Saver S-242T (Stair Chair) Specifications Quantity up to 135

- -The chair must weigh no more 16 kg and allow the movement of patients up to 180 kg.
- -The chair must be approved for use by a single operator and for emergency evacuations and be safe during transportation. It should have backrest, telescopic handles with 3 settings, rear handles.
- -It must have a rear fold out track system During transport on the ground it must have rear wheels and front swivel wheels to provide good maneuverability .

#### Features must include:

- Patient weight capacity up to 180 kg
- Chair can be used by a single operator on scales short haul and evacuation emergency situations
- Rigid and light track system, smooth action on any kind of stairs
- Frame made of high strength aluminum alloy
- Telescopic front transport handles, adjustable (3 settings) with ergonomic grip
- 4 position telescopic rear handle (available in angled or straight versions)
- 4 point patient restraints
